

Terms and Conditions

1 Booking

- i Newton Rigg College will endeavour to provide the courses as indicated; on the dates stated, the price indicated and in accordance with the relevant syllabus.
- ii Please sign and return the booking form within 14 days to confirm your booking.
- iii Return of the completed booking form does not guarantee that a course will run.
- iv Bookings must be accompanied by payment as follows:

2 Payment of fees—general public

- Payment should be made in advance by—
- i cheque made payable Newton Rigg College, accompanied by your completed application form
 - ii credit/debit card booking, with completed application form.

3 Payment of course fees—business customers

- i settlement is required within 21 days from the date of the invoice
- ii if you wish us to invoice your employer a letter of intent or purchase order from your employer should be included with the booking form. Without this we are unable to guarantee holding your place for more than 14 days.
- iii Invoices will normally be sent within 10 days after training.

4 Payment of registration and certificate fees

- i registration, certificate, assessment and exam fees should be paid with the tuition fees at the time of booking.
- ii course members will be required to confirm acceptance of payment for non-refundable fees.

5 Change or cancellation of booking

- i In most cases delegates can be substituted at any time prior to the commencement of the course (but please check with the College)
 - ii if you cancel less than 7 working days prior to the first day of the course. You will be held responsible for the full cost of the training plus any costs incurred by the College in respect of exam papers, books etc.
 - iii Where a cancellation is made with more than 7 working days notice, the College will refund any fees paid less any costs incurred by the College in respect of exam papers, books etc.

Cancellation will take place only in exceptional circumstances and maximum notice will be provided to all candidates.
